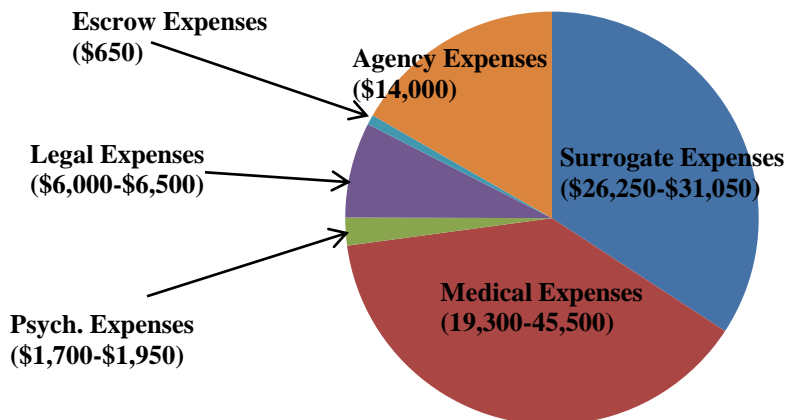

## General Intended Parent Fee Schedule\*

### For Surrogacy:

<b>Surrogate Expenses</b>	<b>(\$26,250 – \$31,050)</b>
~ Surrogate Compensation	\$22,000 - \$25,000
~ Embryo Transfer and Bed Rest	\$ 750
~ Monthly Allowance (includes costs for calls, parking, childcare, postage, vitamins, and mileage <50 miles from appointments; Usually \$200 to \$300/month for 15 months)	\$3,000 - \$4,500
~ Maternity Clothing Allowance	\$500 - \$800
<b>Medical Expenses</b>	<b>(\$19,300 - \$45,500)</b>
~ IVF, Testing/Screening, Labs, Medications, Co-pays, Ultrasounds, Doctor visits (varies in part due to health insurance coverage)	\$18,000 - \$30,000
~ Life Insurance	\$300 - \$500
~ Health Insurance (Varies depending on Surrogate's current insurance policy, if any)	\$1,000 - \$15,000
<b>Psychological Expenses</b>	<b>(\$1,700 - \$1,950)</b>
~ Surrogate's Psychological Evaluation	\$500 - \$750
~ Psychological Support (monthly support meetings; Typically \$100/month for 12 months)	\$1,200
<b>Legal Expenses</b>	<b>(\$6,000 - \$6,500)</b>
~ Surrogate's Attorney's Fees (Agreements review)	\$1,000
~ Intended Parent(s)' Attorney's Fees (Agreements, Parentage)	\$2,500 - \$3,000
~ Pre-Birth Judgment (\$2,500 plus the cost of court fees (varies))	\$2,500
<b>Escrow Expenses</b>	<b>(\$650 plus)</b>
~ Account and Management Fee (Plus \$10-\$15 "per check fee" (varies))	\$650
<b>Agency Expenses</b>	<b>(\$14,000)</b>
~ Program Fee	\$14,000
<b>PROGRAM BASELINE TOTAL:</b>	<b>\$67,900 - \$99,650</b>

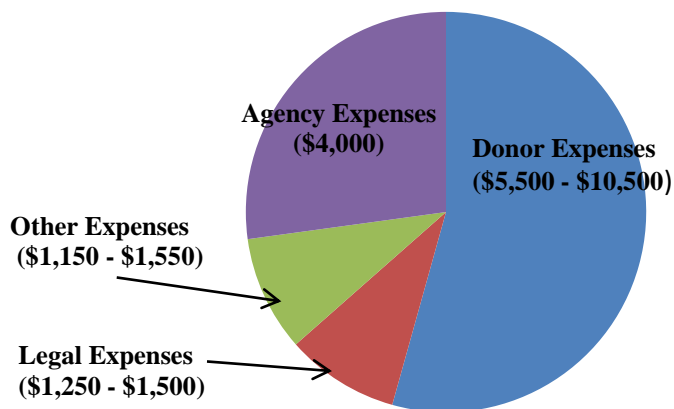


### **Surrogacy Variable Expenses**

~ Twin Compensation	\$5,000 - \$7,000
~ Experienced Surrogate (Additional Compensation)	\$5,000 - \$10,000
~ Mock or Dropped Cycle	\$500
~ C-Section	\$1,500 - \$2,000
~ Lost Wages (Net Wages)	TBD
~ Additional Housekeeping & Childcare (Dr. Ordered Strict Bed-rest)	TBD
~ Invasive Procedures (i.e. Amniocentesis, Abortion, Selective Reduction, CVS, D&C, etc.)	\$500 - \$1,500
~ Loss of reproductive organs (uterus loss, hysterectomy, tubes lost)	\$2,500 - \$4,500
~ Travel Fees (>50 miles from appointments)	TBD

<b>Donor Expenses</b>	<b>(\$5,500 - \$10,500)</b>
~ Donor Fee	\$5,000 - \$10,000
~ Donor Incidentals Deposit (Varies)	\$500
<b>Other Expenses</b>	<b>(\$1,150 - \$1,550)</b>
~ Psychological Evaluation	\$350 - \$500
~ Genetic Evaluation	\$250 - \$400
~ Escrow Account Fee and Maintenance	\$350
~ Donor Insurance	\$200 - \$300
<b>Legal Expenses</b>	<b>(\$1,250 - \$1,500)</b>
~ Donor’s Attorney’s Fees (Review Agreement; Varies)	\$500
~ Intended Parent(s)’ Attorney’s Fees (Agreements)	\$750 - \$1,000
<b>Agency Expenses</b>	<b>(\$4,000)</b>
~ Program Fee	\$4,000
